2. The construction on Taxiway A2 and the GA Apron continues. Some delays were experienced due to the blacktop failing to meeting aviation specifications. The blacktop was completed last week and now they are continuing to work on sod, leveling, edging, raising the taxiway, lights and painting. An 80% walk through still must be completed.
3. Mr. Harma introduced fair sign-up sheets for any members wishing to volunteer at the Airport booth for both the Iron County and Gogebic County Fairs.
4. Mr. Lorensen addressed when the new ARFF truck will begin use. Mr. Harma stated that the staff needs training and we are still awaiting vehicle components that were shipped separately. The older model ARFF truck can still be utilized until the new ARFF vehicle is ready to put in use.

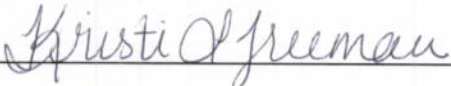
Adjournment
